Please read carefully! This is a legal document, which affects your legal rights!

I desire to engage in recreational activities while attending an event at the Rock Center, at or near 999 Cumberland Ave., Syracuse, NY 13210. I understand that the activities may include but are not limited to sports, dance, art, and other cultural activities. I am signing this Release freely and voluntarily.



1. WAIVER AND RELEASE

I hereby release and forever discharge and hold harmless, the CNY Chinese Culture Center, Rock Center, their affiliated organizations and its successors and assigns from any and all liability, claims and demands of whatever kind of nature, either in law or in equity, which arises or may hereafter arise from my attendance at Rock Center. I understand that this Release discharges the CNYCCC and Rock Center from any liability or claim that I may have against CNYCCC or Rock Center with respect to any bodily injury, personal injury, illness, death or property damage that may result from my attendance at Rock Center, whether caused by the negligence of the CNYCCC or Rock Center or its affiliated organizations, officers, directors, employees, agents or otherwise. I also understand that, except as CNYCCC or Rock Center has disclosed in writing, CNYCCC or Rock Center do not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health or disability insurance, in the event of injury or illness.

2. MEDICAL TREATMENT

I hereby release and forever discharge CNYCCC and Rock Center from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with my attendance at Rock Center.

3. ASSUMPTION OF THE RISK

I understand that there may be activities that could be hazardous to me and that the weather, ground conditions, presence of wildlife and other participants are beyond the control of the CNYCCC and Rock Center. I hereby expressly and specifically assume the risk of injury or harm in these activities and release CNYCCC and Rock Center from all liability for injury, illness, death or property damage resulting from the activities I participate in at Rock Center.

4. INSURANCE

CNYCCC or Rock Center does not carry or maintain, and expressly disclaims responsibility for providing any special health, medical or disability insurance coverage for me. I AM EXPECTED AND ENCOURAGED TO ARRIVE WITH MEDICAL OR HEALTH INSURANCE COVERAGE IN EFFECT.

5. PHOTOGRAPHIC RELEASE

I hereby grant and convey unto the CNYCCC and Rock Center all right, title and interest in any and all photographic images and video or audio recordings made by the CNYCCC or Rock Center during my attendance, including, but not limited to, any royalties, proceeds or other benefits derived from such photographs or recordings.

6. AGE RESTRICTIONS

Adult supervisors or parents accompanying persons younger than 18 years old assume responsibility of compliance.

7. OTHER

I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of New York, and that this Release shall be governed by and interpreted in accordance with the laws of the State of New York. I agree that in the event that any clause or provision of this Release shall be held to be invalid by a court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
